AGENDA FOR THE GAZA STRIP-JERICHO AREA NEGOTIATIONS

- 1. Scheduled and accelerated withdrawal of Israeli Military Forces from the Gaza Strip and Jericho Area.
- 2. Definition of the Jericho area.
- 3. Arrangements for the assumption of internal security and public order of Palestinians by the Palestinian police force:
 - a. Building of the police force.
 - b. Deployment and phasing.
 - c. Liaison and cooperation
 - d. Redeployment of Israeli military forces.
 - e. Free movement of Israeli military forces and civilians.
 - f. Common security issues.
- 4. Arrangements for coordination between the two parties regarding passage and passages:
 - a. Gaza Egypt
 - b. Jericho Jordan
 - c. Safe passage between the Gaza strip and Jericho area.
- 5. Temporary international or foreign presence.

- 6. Arrangements for a smooth and peaceful transfer of Authority to the Palestinian authority:
 - a. Structure, powers and responsibilities of the Palestinian authority.
 - b. Modalities and schedule for transfer of authority.
 - c. Modalities for entry of the Palestinian leadership.
- 7. Palestinian Israeli economic cooperation.
- 8. Definition of the locations and areas of settlements.
- Confidence building measures and other transitional arrangements.

Notes:

- 1. The Parties may discuss the items listed above in any particular order they agree upon.
- 2. Each party is free to raise any further topic for discussion.

Scope and Composition of Committees

- 1. To ensure substantive, detailed and efficient negotiations the following have been established:
 - a. A General Committee (plenary) which will be responsible for the overall negotiations.
 - b. Working Groups, which will be created in order to conduct detailed negotiations regarding their assigned topics, as set forth below.
- 2. The General Committee (plenary) consists of up to eleven members from each party. Any changes will be made by common consent.
- 3. The following Working Groups have been established initially:
 - a. A Security Group, consisting of up to seven members from each side. This Group may form sub-groups, as necessary.
 - b. A Civil Matters Group, consisting of up to seven members from each side. This Group may form sub-groups, as necessary.
- 4. The Parties have decided to establish within the Security Working Group a sub-group to discuss CBMs (prisoners, etc.).
- 5. The General Committee will convene as needed in order to discuss the main principles and concepts of the Declaration of Principles in light of the common agenda, supervise and guide the Working Groups, and receive reports on their progress.
- 6. Next week, the General Committee will commence the negotiations by discussing the main security and civil aspects of the Declaration of Principles.
- 7. The General Committee and its Working Groups will conduct negotiations simultaneousley in Taba or in any other location, as agreed.
- 8. Each Working Group will agree on the detailed topics for its deliberations.
